Councillor Privacy Notice

When you sign your acceptance of office and take your seat on Lane End Parish Council:

The information you provide (personal information such as name, address, email address, phone number, register of interests and other relevant information) will be processed and stored so that it is possible to contact you, respond to your correspondence and retain information relating to your time in office with the Council. Your personal information will not be shared with any third party other than those related to a statutory or lawful requirement or with your consent. As a Parish Councillor your name & address is available in the public domain mainly but not solely via the Lane End Parish Council website, noticeboards and in the Contact magazine.

The Councils Right to Process Information

Processing is with consent of the data subject

Processing is necessary for compliance with a legal obligation

Information Security

Lane End Parish Council cares to ensure the security of personal data. We make sure that your information is protected from unauthorised access, loss, manipulation, falsification, destruction or unauthorised disclosure. This is done through appropriate technical measures and relevant policies.

We will only keep your data for the purpose it was collected for and it will be kept during the whole period of your office and for a statutory period of six years after. After which it will be deleted.

Your Rights

Lane End Parish Council does not use automated decision making or profiling of personal data.

To Sum Up

In accordance with the law, we only collect a limited amount of information about you that is necessary for correspondence, information and service provision. We do not use profiling, we do not sell or pass your data to third parties. We do not use your data for purposes other than those specified. We make sure your data is stored securely. We delete all information deemed to be no longer necessary. We constantly review our Privacy Policies to keep it up to date in protecting your data.
