3) Minutes – Approval of the Full Parish Council Meeting on 1 st February Council approved the minutes. The Chairman will sign the minutes at a future meeting.	
4) Matters arising from previous meeting Cllr Coulter reported that the sale of the Chalky Field site is progressing, and he hopes we can exchange contracts in the next few weeks.	Action Clerk

9) Clerk's report

- i. Allotment tenants at Chalky Fields have asked for a padlock on the gate, a sign, to close the gate and reflectors on the posts. They have also asked for the chicken wire to be repaired. Works have been completed.
- ii. I attended the first Rural Broadband Steering Group Meeting. Contact list written and sent to Rosie & Neil
- iii. I have set up a zoom account for the Rural Broadband group. Cost £145.
- iv. Buckland Landscapes has agreed to continue the grass cutting for a further year with a 1% inflation increase.
- v. Bartlett Tree Surgery propose planting a beech tree to replace the fallen oak tree in Ridge Close. The cost is £780.00.
- vi. The May Parish Council Meeting was scheduled for Monday 10th May. Councillors won't know if they have a seat until Saturday 8th May. If we have new Councillors, they won't have had long to look through the agenda pack. Therefore, I have changed the date of the Annual Meeting of the Parish Council (where the Chairman is elected) and the normal Meeting to Thursday 13th May.
- vii. The donation to the Lane End Players has been paid as agreed at the last PC meeting. The Lane End Players thanked he PC for the donation.

Nineacres Bungalow Fingest Lane Fingest

Construction and provision of new access track from Fingest Lane to serve Nineacres Bungalow and to replace current substandard track

Following the application in 2020 (20/05234)FUL) the planning department made the following observations that appear to still be valid:-

"The proposed formation of an access road would result in a permanent and adverse change to the landscape character of this part of the Chilterns AONB, which is likely to be visible in part in views from the west / southwest of the site. The proposed development would result in: - A permanent and substantial change to the site topography, uncharacteristic of a farmland hillside- Exposed chalk faces, especially on steep cuttings where revegetation is difficult. These would be visually prominent in the landscape, where there are partial/glimpsed views from the west / southwest. - No ongoing practical use of the field for agriculture (e.g. grazing farm animals or horses). It therefore effectively becomes residential curtilage, with the 'front gate' at the roadside on Fingest Road, in the AONB. Loss of existing green infrastructure features. The proposal, as submitted, does not achieve the required visibility splays to the left upon exit. It has not been demonstrated, through the submission of suitable evidence, that the proposed access would not result in a detrimental impact upon the safety of the public highway. Therefore in the absence of sufficient information, it cannot be demonstrated that there would not be a detrimental impact on highway safety. (Highways no objection as long as development is in accordance with agricultural vehicle access rules)

There is an alternative to the development, i.e. using the existing access."

Application for approval of details subject to Conditions 4 (Car port screens), 8 (Bird/bat boxes) and 18 (Water efficiency) of planning ref: 17/06891/FUL.

Belmont House High Street Lane End

Prior notification application (Part 3, Class O) for change of use of existing building falling within Class E use (Offices) to Class C3 use (Dwellinghouses) to create 1 x 1-bed flat and 1 x 2-bed flat (2 units in total). No objection.

21/05199/FUL

Laurels Moor Common Lane End

Householder application for raising of roof in connection with loft conversion and display of array of solar panels.

No objection.

21/05169/FUL

15 Clayton Road Lane End

Householder application for construction of single storey rear extension and insertion of new door to garage. No objection.

21/05142/FUL

High Barns Marlow Road Cadmore End

Demolition of stables and erection of a 2-bed detached dwelling.

The PC object to this proposal on the grounds of significant local opposition/objection (21) citing noise/pollution due to the proximity of the M40 (the noise survey was carried out during the current pandemic with significantly reduced traffic flow), inappropriate development in the green belt/AONB together with the erection of an acoustic fence (which is against the openness policy of the Green Belt), historic planning issues with this site, lack of use of the current facilities that have only recently been completed, the development is not part of the local plan & the fact that exceptional permission was granted in 2014 for an equestrian facility for outdoor sport/leisure pursuits only.

On the basis that refusal to this application is the agreed outcome, we would seek confirmation that the conditional consent applicable on previous determinations regarding traveller caravan accommodation and compliance with the approved Highways access design are not extinguished.
