November 2023 - The items below summarise the Clerks activities since the last meeting.

- 1. There has been a number of issues with three streetlights on footpath 25. SSE were supposed to carry out repairs on a number of occasions. SSE repaired one, the other one is still awaiting repair and one is flickering. New target date of 28.12.23.
- 2. As agreed, I have arranged for M H Groundcare to plant the new tree at Ridge Close. He will put compost in the bottom and a pipe for watering. This will need constant water next spring, summer and autumn. We need a volunteer to do this.
- 3. A contractor working on behalf of SSE will carry out the following works: Following a survey of a 11Kv OHL (overhead line). Works are required on a hedge & ash tree at the allotments off Marlow Road (B482), between Cadmore End & Bolter End (please see maps beneath). A grid of SU7932 9249, Three words encoder.stretcher.outsmart. These works are required at this location for the safety of the public, surrounding area & continuity of supply. Date to be confirmed.
- 4. I asked M H Groundcare to carry out some works on a tree on Denham Road that was shadowing a street light. The quotation for this was £50.00, he combined this with other works.
- 5. I have written to a property occupier on Park Lane and requested they cut back the hedge completely blocking a footpath. This has not yet been done and no correspondence received. I have written a second letter. I have received a quotation for the works of £790.00 plus VAT.
- 6. The draft precept and budget will be distributed to Councillors in January.
- 7. Re the street lighting in Cadmore End, I have contacted the Police to ask their view on switching the lights off permanently. Their feedback was that lack of street lightening can lead to an increase in anti-social behaviour and crime.
- 8. I have also asked the Cadmore End Residents Association to confirm the exact columns that are causing the issue and then I will obtain costs for shields and timers.
- 9. I have asked the Police for an update re the Community Speedwatch Scheme. Awaiting info.
- 10. I asked the contractors to take the foliage as low as possible round the top pond.
- 11. The Baby and Toddler group thanked the Parish Council for the donation.
- 12. I have contacted two contractors and asked them for quotation for the removal of the stump on Ditchfield Common, awaiting quotes.
- 13. The Clerk has done 8 hours overtime, the Chairman agreed this should be paid accordingly.
- 14. There was a hole in the ground by the drainage pipe on The Row, this was deemed a hazard and it has been covered.
- 15. I have contacted TFB and asked them to cut back some more of the hedges on Bolter End Lane.
- 16. It has been confirmed that the planning permission for the ex Peacock pub site has expired.
- 17. Cllrs Coulter, Nicolson and Osborn will attend the meeting with the Village Hall Committee re the regeneration project. Awaiting date.
- 18. Cllr Detsiny laid the poppy wreath on behalf of LEPC at the recent Remembrance Day Service.
- 19. Christmas in the Village will be on Friday 8th December 2023, Lane End Village Hall from 5.30pm.
- 20. Contacted Buckland Landscapes re the grass cutting on the village green. The Village Green is scheduled to be cut every two weeks during the growing season.
- 21. Advised M H Groundcare to carry out the works of cutting back the foliage around the street lamps on footpath 25.
- 22. Frieth school has confirmed that pupils attending their school from Lane End Parish is between 30% and 50%.
- 23. The AED units on the circuit website have been updated.

- 24. Reported various issues on fixmystreet.
- 25. Fixmystreet is available via an app on your mobile phone, it detects your location and you can take a photograph to upload and submit. It's the easiest way to report issues to Bucks Council.
